- Interest payments typically floating rate

- Dividend coverage each quarter since inception

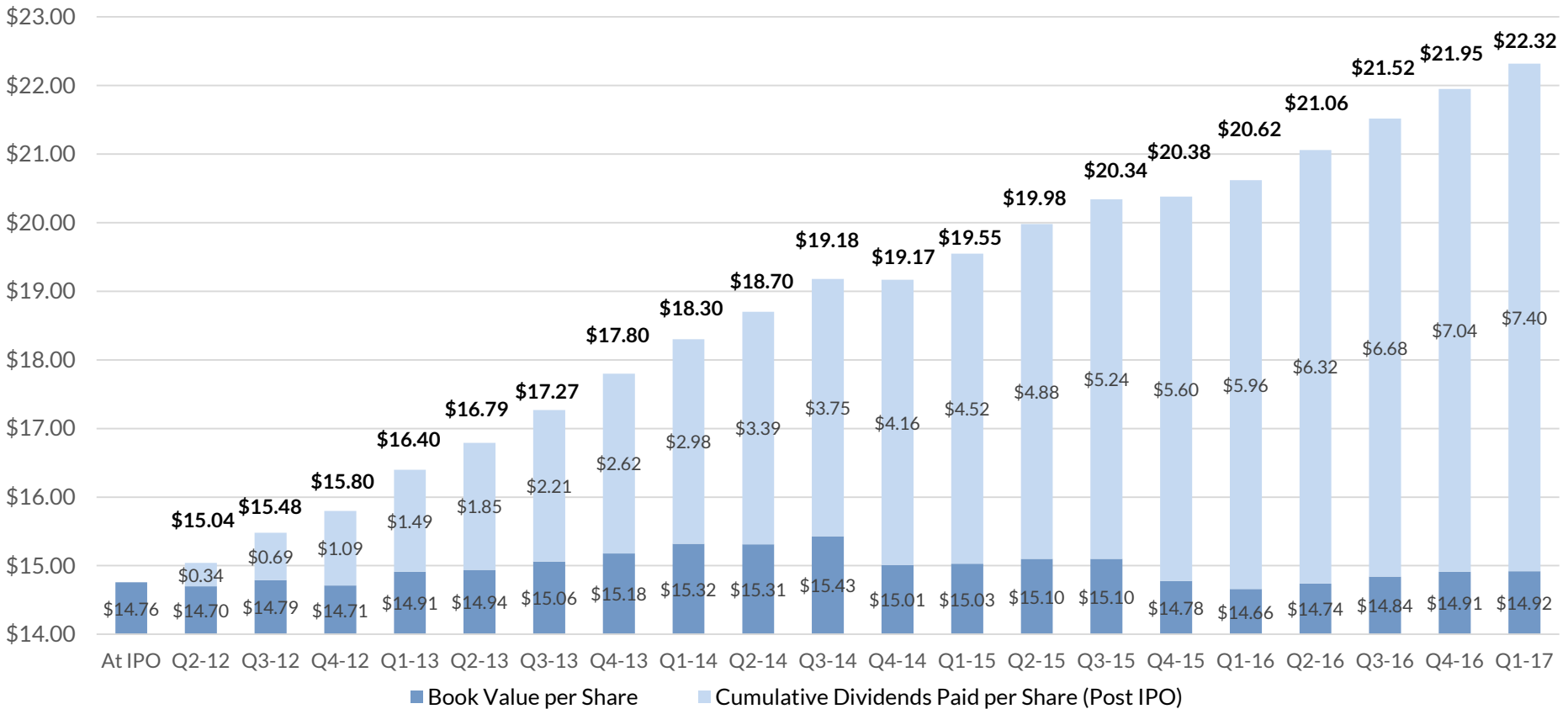

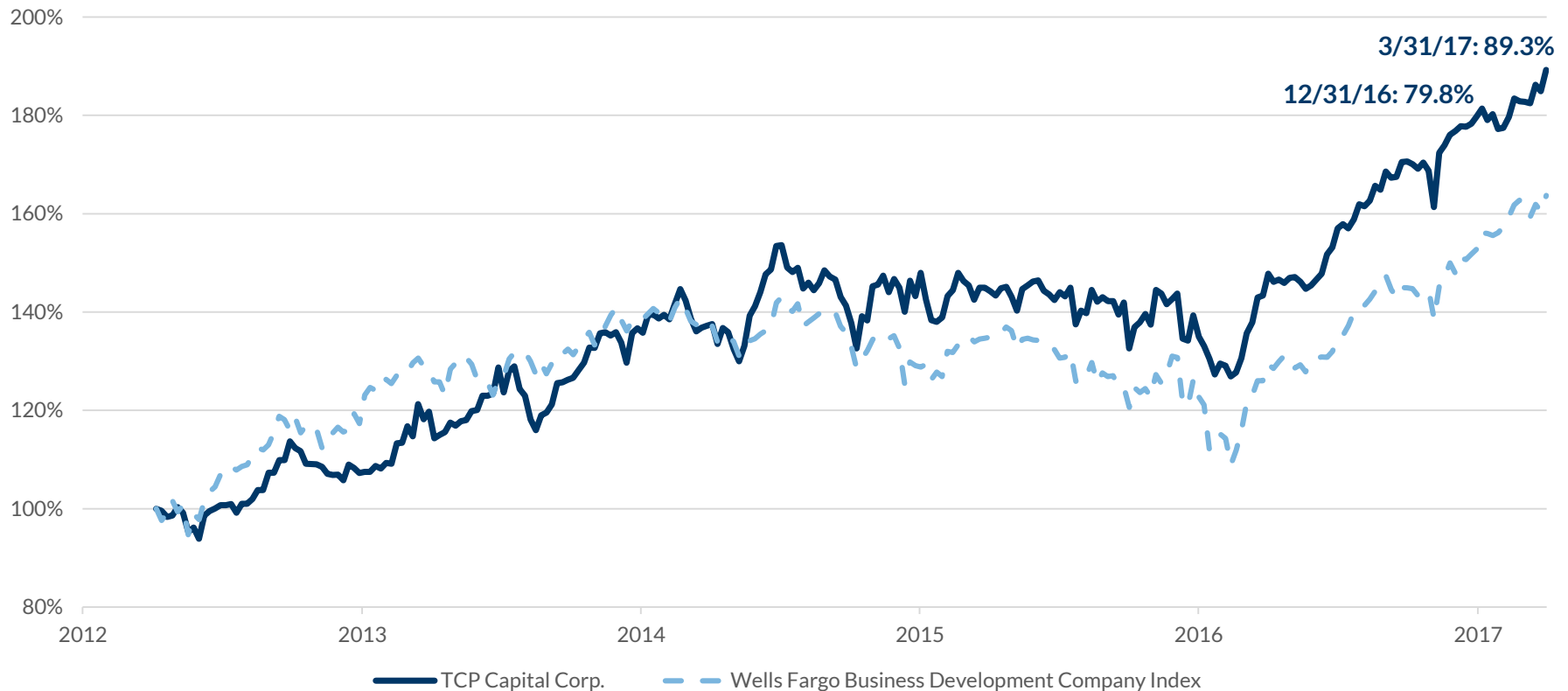
Book Value per Share and Dividends Paid

Out-performed the Wells Fargo BDC Index

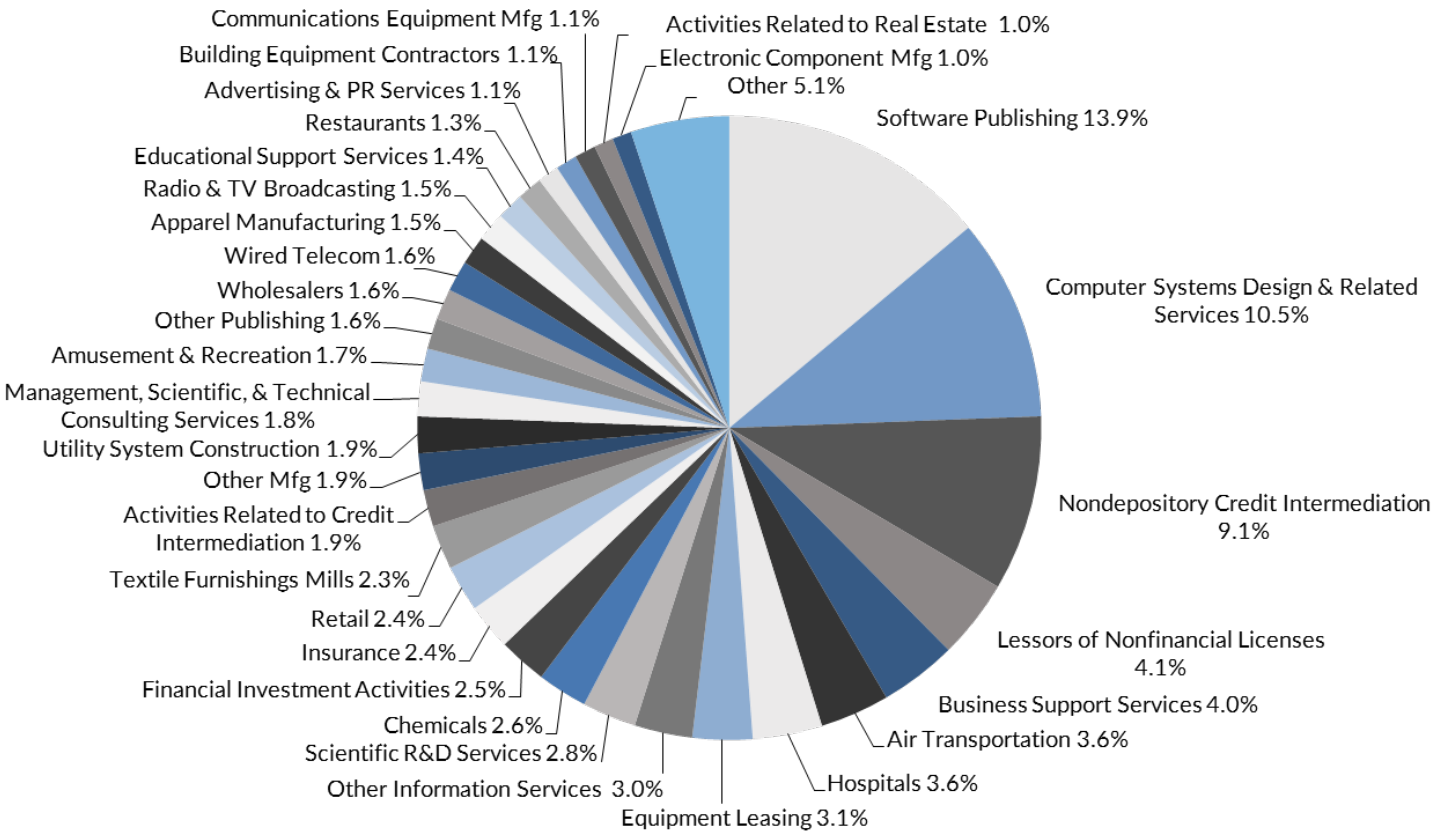
Total Return Performance⁽¹⁾

- 11.1% weighted average effective yield on debt portfolio⁽¹⁾

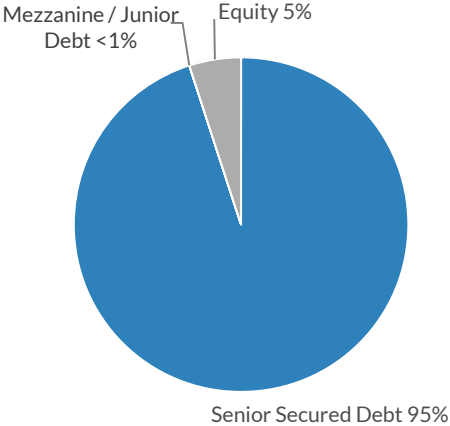

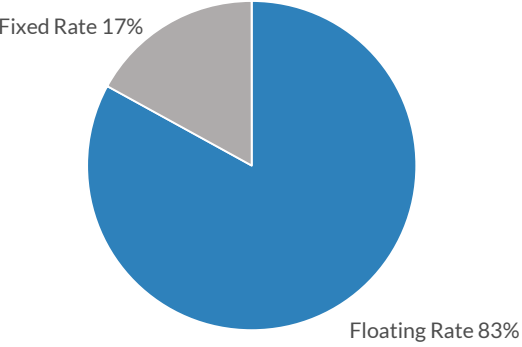
Conservatively Positioned Portfolio

As of March 31, 2017

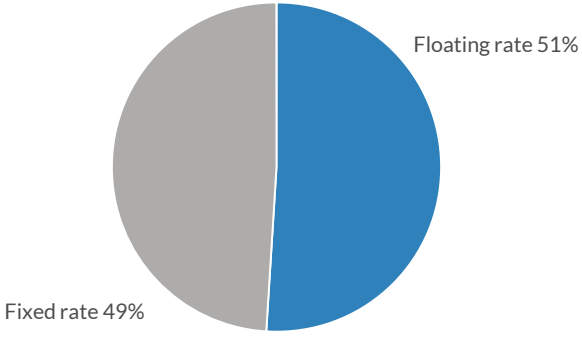
Portfolio by Asset Type
